



# Community Grants Funding Guide



Postcode Community Trust funds projects in Great Britain. These projects can be up to 12 months in length. Postcode Community Trust will consider projects which improve health and wellbeing through:



**Grassroots sports**  
 arts and recreation projects  
**that improve** health  
 and **wellbeing**

Projects that **improve**  
 the **health of communities**  
 through, for example, **first aid courses,**  
 befriending, **counselling** or  
 reducing isolation

### Application process

#### STAGE 1

##### Expression of Interest (EOI)

Requires basic details about your organisation, as well as a very short summary (500 characters) of the project you are proposing.

#### STAGE 2

##### Full Application

This stage requires applicants to provide more detail on both their organisation and the project, for example:

- **core aims and activities of the organisation**
- **outlining the project need and main activities**
- **full breakdown of the total project costs**

## We do not fund:



organisations currently in receipt of funding from players of the People's Postcode Lottery, including previous grant recipients who have not submitted a project evaluation form

running costs not directly relating to the project

bodies seeking to distribute grants/funds to others

organisations with restricted or exclusive memberships

applications where our funding would be less than 10% of the overall project cost

organisations that have previously breached their funding agreement with Postcode Community Trust



political parties or party political activities

projects that promote religion

local councils (including local authorities, parish councils and town councils)

schools (except for special schools), PTAs, nurseries, playgroups and universities/colleges

lunch clubs, parent councils, mother and toddler and after-school groups

individuals

feasibility studies

foreign travel

general marketing appeals or sponsorship



medical research, advice and equipment

end of life or palliative care

short-term projects such as events, conferences, trips, seminars, holiday clubs, galas or festivals

training or educational workshops that do not result in a tangible outcome for participants



building renovations/general refurbishment

installations of toilets, showers, lifts or changing rooms

organisations that appear to have excessive unrestricted or free reserves and no policy to reflect the rationale behind this

projects or activities that the state has a legal obligation to provide

*Please note that applicants can only apply to one trust supported by players of People's Postcode Lottery each round and may only submit one application per organisation*

## Case Studies

**Denis Law Legacy Trust** – in order to help young people gain access to sport activities in their communities a “Tennis on the Road” project was funded through PCT.

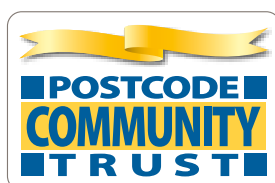
The main aim of the programme was to reduce levels of youth related anti-social behavior within the community while also increasing health and wellbeing of young people in the community through sports.



The **Dementia Care Farm** project provides therapy for people living with dementia through different activities such as clay modelling and singing, in a therapeutic environment. The project created a social space and network for the beneficiaries and provided an excellent respite opportunity for carers which also helped relieve isolation.




**Golden-Oldies** is a social initiative, bringing positive change and improving the wellbeing of older, marginalised and visually impaired people in Wales. The group received funding to provide structured, daytime social singing and activity sessions that encourage participation and functional exercise.
